The PhD in Heritage, Technology and Territory (DPTT) is an advanced training and research program offered by Universidade Autónoma de Lisboa and the Polytechnic Institute of Tomar and includes collaborations by academics from the four continents. DPTT is an innovative training using a **Distance Learning Model** that focuses on the relevance of heritage materialities to the dynamics, resilience, and sustainability of human societies.

This notice, in line with the General Regulation on Master and PhD Programs at Universidade Autónoma de Lisboa (no. 564/2019) and the Regulation on the PhD in Heritage, Technology and Territory, lays down the application criteria for the 2nd edition of DPTT, which is to start in the second semester (March of 2024) of the academic year 2023-2024.

The specific rules are laid down in DPTT regulation, which accounts for the specificities and demands of an innovative and unique program within the educational project of UAL and IPT.

Accreditation of the study cycle and duration of the program as published in *the Official Gazette*, 2nd series, part E no. 210 on 31st October 2022, pp. 91 to 95.

### Applications

Pursuant to Article 3 of Chapter I of the Regulation on the PhD in Heritage, Technology and Territory.

Applications must include the following documents:

- a) Photo and copy of identification document;
- b) Application form;
- c) Copy of certificates (\* must include the final grade and the grades obtained in each course unit;
- d) Detailed Curriculum Vitae;
- e) Other relevant documents;
- f) Sworn statement on the documents included in the Curriculum Vitae;
- g) Application letter;
- h) Two recommendation letters.

Applicants to the PhD in Heritage, Technology and Territory should meet the requirements laid down in article 30 regarding academic degree diplomas and higher education diplomas in the updated version of Decree-Law no. 65/2018, dated 16 August, and who hold a master's degree in the scientific fields or in similar fields to those of this program.





## Selection criteria

Candidate selection shall be carried out through general assessment on the candidates' CV, including:

- a) Education 20%
- b) Academic and scientific publications 20%
- c) Research projects 20%
- d) Professional career 10%
- e) Application letter- 10%
- f) Two reference letters 5%
- g) Interview 15%

## **Decision criterion**

In the event of a tie, the holder of the highest degree title will be selected. In the case of applicants holding equal qualification, the applicant with the higher final grade will be selected.

### **Applicant Selection Commission**

The Applicant Selection Commission will include the program coordinators, two (2) program lecturers, one from the UAL and another from IPT, and one (1) invited external lecturer.

### Scholarships

Scholarships are available with total or partial reduction of the tuition fees, to be evaluated every semester based on the student's excellence, according to the Regulation for the Award of Research Scholarships in force at UAL and IPT.
