HERITAGE. TECHNOLOGY AND TERRITORY

The PhD in Heritage, Technology and Territory (DTPP) is an innovative distance education degree program. Its focus is the study of heritage materiality's and their relevance for the dynamics, resilience, and sustainability of human societies, understanding in this process two main dimensions: technology (human materials) and territory and the construction of cultural landscapes around the heritability of the products of ancient technologies (heritage, technologies, and cultural landscapes).

Available techniques that are inseparable from culture identity and made everlasting are what we define as heritage. This heritage is both tangible (objects. structures) and intangible (knowledge, processes) and part of the cultural identities it emerges from, among which societies' exchange routes. Understanding this process has become a topic of international scholarly debate, as well as s concern for intergovernmental institutions, such as UNESCO, having led to the creation of new concepts (such as that of cultural landscape), new management tools for specific locations and new tools to promote sustainability that change its paradigm (such as the program BRIDGES).

DPTT, considering the complementary collaboration experience between UAL and IPT, is an advanced training program in the context of research, linked with two R&D centres assessed as Excellent and Very Good, as well a wide network of partnerships with HEIs and other entities throughout the world. Besides its link with research centres to integrate PhD students in multidisciplinary research teams.

It is supported by the programs of the Centro de Geociências, Centro Techn&Art, UAL Chair in Luso-Brazilian History and Culture and the UNESCO-IPT Chair in Humanities and Cultural Land Management. Designed as a research program, the DPTT will prepare doctoral students towards autonomy and self-learning, including the development of transversal skills with a focus on teamwork.

All PhD students will become members of one of the centres, in accordance with their research topic and its internationalization in terms of partnerships with other HEI and other organizations, such as UNESCO, key for wide scope comparative research and ensure access to a wide network of researchers, analytical tools and
